Dear Friend,

Many Los Angeles and San Gabriel Valley families are missing out on a valuable tax benefit for working families: the Earned Income Tax Credit (EITC). The EITC is a refundable federal income tax credit for working individuals and families. I am committed to ensuring that this valuable program is accessible to all that are eligible for it.

If your family earned less than \$38,348 in 2006, you may be eligible for the EITC. The EITC amount depends on factors such as earned income, total income, and family size, but the maximum credit for 2006 is \$4,500. Even if you did not claim the EITC in the past, you can amend earlier returns and claim the credit.

I have also included a list of locations that can provide you with assistance in filing your taxes.
